Overview of Municipal Services Tariffs 2014/2015

The ever-rising cost of living and the limited resources available to absorb that cost has made it necessary for everyone to carefully scrutinize and keep proper record of what one is paying for on a daily basis. The Lüderitz Town Council embarked on a campaign to inform the community about the recently gazetted tariffs and the impact thereof on customers' municipal accounts.

This tariff booklet is structured in such a manner to make it easier for customers to understand the new tariffs. Should your monthly invoice or statement not give a true reflection of the gazetted tariffs and you are either overcharged or undercharged, do not hesitate to notify our Revenue Office in order for the potential error to be corrected in good time. Omitting to point out an error earlier may result in backdated charges being applied once the discrepancy is eventually detected and that may put your account in unnecessary arrears and inconvenience.

An overall comprehensive review of the Lüderitz Municipal Tariff Structure was done before the submission of the budget to the Ministry of Regional Local Government and Housing for approval. The tariff structure in the current form is therefore a direct result of the budget projections for the year 2014/2015.

A common utility invoice will generally comprise of the following:

1. Water

Conventional Meter Users: Are charged for the actual metered water consumption per m³ (cubic meter) according to sliding or block tariffs, meaning, the more water used, the higher the tariff per m³. A basic charge is also applicable in addition to the unit price and it is determined by the size or diameter.

Prepaid Meter Users (not invoiced): Communal Prepayment water meters manned by Vendors are now installed in the informal areas where residents previously used water at no charge. Water is sold in 25 litre containers at 30 cents per container, which equals N\$ 12.00 per m³.

2. Electricity

Conventional Meter Users: Are charged for the actual metered electricity consumption per kwh (kilo watt hour). There are two tariffs applicable per annum namely the High Season Tariff and the Low Season Tariff for both residential and business customers. Business customers and bulk consumers with three phase connections and demand meters are further subjected to Peak, Off Peak and Standard TOU Tariffs (Time-Of-Use) i.e a tariff depending on the time of the day that the electricity is consumed. The high season period starts from 01 June up to 31 August and the low season is the rest of the year, from 01 September till 31 May.

The electricity tariffs are generally higher during the winter period due to increased demand.

A basic charge is also applicable in addition to the unit price and it is determined by the size of the circuit breaker. The more amps required, the higher the basic charge.

If your basic charge is too high, check if you really need the circuit breaker of that size, you may save by reducing the amps. The basic charge on demand meters are determined by the metered kilovolt amp (kva).

Prepaid Users (not invoiced): Are charged a flat rate, regardless of the units bought and no basic charge is applicable, however VAT is applicable on business and three phase customers.

The ECB Levy (Electricity Control Board Levy) is determined by the total electricity units consumed (kwh) @ 0.0150 cents per unit and is applicable on both conventional and prepaid electricity. The NEF Levy (National Energy Fund Levy) is determined by the electricity units consumed (kwh) @ 0.0102 cents per unit and is applicable on both conventional and prepaid electricity.

3. Sewerage

The waste water disposal charge is inextricably linked to the water consumption, meaning the disposal charge may differ from month to month, depending on the amount of water used. A fixed basic charge is also applicable. Flats on business zoned properties will be charged at business rates.

4. Sanitation/Cleansing

There is a Removal of Refuse (Standard Container 240L Wheelie Bin) charge and a Disposal Tariff per bin applicable on all residential properties and for business, depending on the number of removals per week. **Note:** *An error was made with the inputting of the new tariffs and the sanitation was undercharged for July 2014 as a result. This error will be corrected with the August 2014 invoices. We sincerely apologize.*

5. Rates & Taxes

The Rates & Taxes are charged according to the Municipal value of the land and improvements or buildings. A building clause tariff equivalent to the improvement tariff is applicable effective 1 July 2014 on all empty plots. See Summary of Applicable Tariffs. **Note,** *the mandatory five year General Valuations of all property under the Municipal jurisdiction of Lüderitz will be conducted soon.* The new property value will most likely increase and that will in turn affect the current rates and taxes charges.

6. Security Deposits

One of the frequent Audit findings for the last three to four years is that the Debtors Security Deposits are not sufficient to cover one month's consumption. The bank guarantees of Commercial entities if any are also not sufficient or equivalent to a month's consumption. It is for these reasons that some of the services accounts for July 2014 are journalised and debited with a certain amount, depending on what is shortcoming to make up for the minimum required deposit as gazetted. It is arguably not the most preferred option, but then,

all previous notices for debtors to update deposits yielded little results.

7. Fire Brigade

The monthly Fire Service Levy was introduced in 2013/2014 financial year, but it was not applied. This new levy will soon feature on the monthly services invoices. The Ministry of Regional, Local Government and Housing availed funds for the construction of a fire station for 2014/2015 financial year. Lüderitz is prone to fires especially in the informal areas. The regular maintenance or upkeep of the fire station is of critical importance; hence the fire levy.

Other Matters

Pensioners

Provision is not made for Support Tariffs for pensioners for 2014/2015 as reflected on the July 2014 services invoices. This should not be miss-understood as renegeing on social responsibilities as Council is working on modalities to address the plight of the elderly. The Government also hinted that it is working on a support mechanism to alleviate the burden of utility bills on senior citizens and any new development in this regard will be duly communicated to the public.

The implementation of a support tariff for the elderly on the other hand is also compromised by the fact that the economically active and able-bodied youth who are staying with the elders are benefitting directly from these subsidies and that defies the objective. The community development division is tasked with coming up with some sort of profiling or database

on pensioners so that the Council can make a better informed decision with regards to support tariffs.

It is also worth mentioning here that despite the odds and their meagre income, our Senior Citizens are the most committed customers when it comes to the payment of Municipal services and whenever circumstances dictates otherwise, they always attempt to notify the office in good time and make necessary arrangements for an extension. This is so commendable and we urge the working younger generation to emulate these noble gestures from our Pensioners and at least try to pay our Municipal bills and also assist our elderly with their payments and not shy from responsibilities by mounting the bandwagon of subsidies that are essentially meant to assist the elderly.

Illegal Connections and Tempering

The Council is aware of a growing tendency amongst the public to bypass water and electricity meters. The public is cautioned that Peace Officers have recently been appointed to monitor these types of transgressions. If your meter is found to be tampered with, you will be charged retrospectively for consumption (from the date that the theft is suspected to have started). Criminal charges will be laid against you at the Police. Customers' purchase history or consumption trends can be monitored on the system and if any deviation or spikes in usage is detected, it will be investigated.
